Saturday - Sunday 12 noon - 3 p.m. & 4 p.m. - 6 p.m.

Water will be off between 3:00 p.m. and 4:00 p.m. for maintenance

SPLASH PAD RULES

WATER WILL NOT BE TURNED ON UNLESS RECORDED TEMPERATURE AT MIDWAY IS 74 DEGREES OR ABOVE.

NO FOOD OR GLASS CONTAINERS ARE ALLOWED IN SPLASH PAD AREA.

BEACH/WATER TOYS ARE NOT ALLOWED IN THE SPLASH PAD.

CLIMBING ON EQUIPMENT IS NOT ALLOWED.

PLEASE DO NOT HANG CLOTHES OR TOWELS ON FENCE/TREES.

GROUPS OF TEN OR MORE MUST HAVE A PERMIT.

CHILDREN PLAYING IN THE WATER MUST WEAR PROPER SWIM ATTIRE. NO DIAPERS. LITTLE SWIMMERS OR EQUIVALENT IS ACCEPTABLE. NO DIAPER CHANGING IN THE FENCED AREA.

PARK DISTRICT RESERVES THE RIGHT TO LIMIT ENTRY IF THE FACILITY IS AT ITS REASONABLE CAPACITY.

IN THE EVENT OF THREATENING WEATHER OR IF THE PARK DISTRICT'S LIGHTNING PREDICTION SYSTEM ACTIVATES, THE SPLASH PAD WILL BE CLOSED.

PATRONS ENGAGING IN HORSEPLAY WITHOUT REGARD FOR THE SAFETY OF OTHERS & IF YOU VIOLATE THE RULES YOU WILL BE ASKED TO LEAVE AND THERE WILL BE NO REFUND.

Season passes **for residents only** are available for \$8 per child (adults are free) at the Cynthia Neal Center during regular business hours Monday thru Friday 9 a.m. - 5 p.m. **RESIDENTS MUST PRESENT EACH CHILD'S GOVERNMENT ISSUED BIRTH CERTIFICATE ALONG WITH TWO (2) FORMS OF IDENTIFICATION TO OBTAIN A PASS.** Only the following are considered acceptable forms of identification: valid driver's license, gas bill, electric bill, water bill or a tax bill. In place of the birth certificate, you can use last year's pass. Address must be within the corporate limits of the Hickory Hills Park District.

Residents may apply for season passes May 2 - May 31. Any passes issued after May 31 at 5:00 p.m. will be charged \$11 per pass. Each child in your family must be issued a pass. They must present the pass for admission to the splash pad. Non-residents are prohibited from obtaining an annual pass and must pay the daily rates as outlined above. If your card is lost or stolen, a \$5 charge will apply.

Splash Pad Party Rentals:

You can host a special party at the splash pad 10:00 - 11:30 a.m. or 6:30 - 8:00 p.m. The rental fee for a resident group is \$125 and the non-resident group rate is \$155, which includes a \$50 refundable deposit. All rental fees are required 7 business days prior to your rental date. All money must be paid before we confirm the date. You can give two checks, one for deposit and one for the rental. The fifty dollars will be refunded/returned by mail the next business day following the party rental date. If any damage is present after the party rental, the deposit will not be refunded. Any group of 10 or more must have a permit. The total number of people attending will need to be included when scheduling the party/rental. The permit is the same hours and fees as listed above for parties. Dates available are June thru August. Call 598-1233 for more information (ask for Tammy).
