

ORDINANCE 2025- 846

AN ORDINANCE PROVIDING FOR THE LEVYING,
ASSESSMENT AND COLLECTION OF TAXES FOR
THE YEAR 2025 OF THE HICKORY HILLS PARK DISTRICT
COUNTY OF COOK, ILLINOIS

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE HICKORY
HILLS PARK DISTRICT, COUNTY OF COOK, ILLINOIS:

SECTION 1

That a tax in the sum of One Million Four Hundred Thirty-Five Thousand Five Hundred and Seventy-Eight Dollars (\$1,435,578) or so much thereof as may be authorized by law, be and hereby is assessed and levied to defray the anticipated expenses and liabilities of the Hickory Hills Park District for objects and purposes hereinafter specified against all taxable property within the limits of the Hickory Hills Park District, at full, fair cash value as the same is assessed and equalized for state and county purposes for 2025:

A. CORPORATE FUND

- Salaries and Wages
- Contractual Services
- Repairs and Maintenance
- Health Insurance
- Equipment
- Office Supplies

B. RECREATION FUND

- Salaries and Wages
- Contractual Services

SECTION 2

The Secretary of the Board of Park Commissioners is hereby directed to file with the County Clerk of Cook County, Illinois, in due time and in the manner prescribed by law, a copy of this Ordinance certified by said Secretary, and said County Clerk shall enter the taxes to produce the amount levied upon the books of the collector of County taxes as provided by law.

SECTION 3

This Ordinance shall take effect and be in full force from and after its passage and approval as provided by law.

SECTION 4

Pursuant to Section 4-4 of the Park District Code (70-ILCS 1205/4-4), as amended, the Park District's budget and appropriation ordinances for the fiscal year commencing on May 1, 2026, and ending on April 30, 2027, and for any other fiscal year, are not intended or required to be in support of or in relation to this tax levy ordinance.
